ORDER

In pursuance of the majority view of Board Members on the Agenda Item No. 5 sent through Circulation vide letter No 1008 dated 11.04.2016, the Board has approved the followings:-

1. Accorded Administrative Approval & Expenditure Sanction amounting to Rs.63,25,68,990/- for construction of 200 Two Bed Room Flats in Sector 51-A, Chandigarh which includes Building work having Civil, Public Health & Electrical components along with the works of Estate Services such as Roads, Horticulture, Water Supply, Storm water drainage, Sewerage system & Street lighting and Electrical & Mechanical Specialized works such as DG sets with CRDI Technology, Passenger lifts, Fire fighting & Fire Alarm systems with maintenance for five years of Estate services works.
2. To go ahead with taking up of construction of 200 Two Bed Room Flats in a single group as a composite work i.e. Building work having Civil, Public Health & Electrical components along with the works of Estate Services such as Roads, Horticulture, Water Supply, Storm water drainage, Sewerage system & Street lighting and Electrical & Mechanical Specialized works such as DG sets with CRDI Technology, Passenger lifts, Fire fighting & Fire Alarm systems with maintenance for two years of Roads & Horticulture works, as per already approved plans of the Department of Urban Planning, UT, Chandigarh by inviting e-bids with time limit of 18 months from the date of commencement of the work. The maintenance of works of PH/Electrical Estate services and rest of the period for Roads & Horticulture works would be executed later on as per actual requirement of work at site.
3. Accorded approval of additional brands to be incorporated in the list of approved brands of CHB.
