In some cases, allottees or their legal heirs have died in foreign countries. On the persistent demand of the general public, in the interest of public service and to facilitate the delivery of services to the general public, it is hereby ordered that in such cases, the applicants should submit separate affidavits of two separate persons as per the attached proforma. These two persons may be relatives of the deceased or persons who knew the deceased. The applicants shall also submit specific indemnity bonds in this respect as per the attached proforma.
