**Subject: - Cancellation order of D.U. No. 4982/3 Sector 38 West
A.A.Y-2009 Sub Scheme -A/27on Hire purchase Basis
Chandigarh.**

1 Where as you had submitted an Application Form No.1072 duly signed by you on dated 14/9/2009for allotment of One Room flat in Sector 38 W Chandigarh under Dr. Ambedkar Awas Yozna -2009.

2 And whereas on the basis of said application you have been allotted D.U. No. 4982/3 Sector 38 West Chandigarh under the above said scheme as a result of draw of lots held on 10/7/2014 and allotment was made vide allotment letter No. H.B(A.O-II)SO-9/SA-2/2015/1025Dated. 19/1/15 but possession could not be released due to misrepresentation of facts by you.

3 And where as after going through the documents it has been found from the computer record that H. No. 2633/3 at Sector 49 under Chandigarh Small Flat scheme -2006 has already been allotted to you and you have submitted wrong information in the shape of affidavit that you and your dependent relation including unmarried children do not own or free hold /lease hold or hire purchase basis or a residential plot or house in U.T. Chandigarh or any Urban state of Mohali or Panchkula.

4 And whereas you have violated the clause No.10 of declaration of the application form No. 1072and clause No. IX of the Brochure of the Scheme of Dr. ambedkar Awas Yozna -2009 and clause No. 20 of the Allotment Letter which makes you ineligible and the registration as well as allotment is liable to be cancelled and the total deposits made till date is also liable to be forfeited.These all clauses are reproduced as under:-

(i) Clause No. 10 of the declaration of application form :- "That the above information is true to the best of my knowledge and belief and


nothing has been concealed therein . If the information furnished by me in the application form or furnished later on at any stage is found to be incorrect /false , the Board shall have the right to cancel the registration / allotment and to forfeit the entire amount paid in addition to the penal consequences under the law. ”

(ii) Clause No. IX of the Brochure of the Scheme of Dr. Ambedkar Awas Yozna “ *If it is found at any stage that applicant has furnished any incorrect or false information or suppressed any material facts in the application form for registration or later on ,which makes him /her ineligible ,the registration as well as allotment of Dwelling Unit ,if made ,shall be cancelled and the total deposits made till date shall be liable to be forfeited. The applicant shall also be liable to penal consequences under the law. ”*

(iii) Clause No. 20 of the allotment letter :- “ *If the allotment is cancelled in the event of the affidavit filed in the prescribed form along with the application or at the time of allotment with regard to the eligibility being found false at any stage ,the Board would in addition to the cancellation of your registration with the Board and the allotment of the Dwelling Unit , forfeit the deposits received with the application and all the payments made to the Board thereafter in addition to the penal consequences under the law. ”*

(5) And whereas you have not replied to the Show Cause Notice issued to you vide this office letter No. 11916 Dated. 23/9/2015 and not attended the hearing before the undersigned on dated.30/9/2015 and 16/11/15, 16/2/16,15/3/16,31/5/16,26/7/16 and 23/8/2016.

Therefore I Chief Executive Officer, Chandigarh Housing Board being the Competent Authority have been left with no option but to cancel the registration and allotment of Dwelling Unit No. 4982/3 Sector 38 W Chandigarh. I further order to forfeit the entire amount Rs. 1,19,535/- deposited by you.
