Subject: Cancellation order of D.U.No.6772-A, sector 56, Chandigarh-Ambedkar  
Awaz Yozna-2009

- 1 Whereas you had submitted an application form No 5543 duly signed by you on dated 16/9/2009 for allotment of one room flat in Chandigarh under Dr Ambedkar Awaz Yozna-2009.
- 2 And whereas on the basis of said application, you have been allotted D.U. No 6772-A, Sector 56, Chandigarh under the above said scheme as a result of draw of lots held on 10.7.2014 and allotment was made vide allotment letter No.H.B.(AO-II)SO-9/SA-2/2015/942 dated 19.1.2015, but possession could not be released due to misrepresentation of facts by you.
- 3 And whereas after going through the documents, it has been found from the computer record that H.No.1789 at Mauli Jagran Chandigarh under 3187 ORT scheme has already been allotted to you and you have submitted the wrong information in the shape of affidavit that you and your dependent relation including unmarried children do not own or free hold/lease hold or hire purchase basis or a residential plot or house in UT, Chandigarh or any urban state of Mohali or Panchkula.
- 4 And whereas you have violated the clause No.10 of declaration of the application form No.5543 and clause No IX of the Brochure of the scheme of Dr Ambedkar Awaz Yozna-2009 and clause No.20 of the Allotment Letter which makes you ineligible and the registration as well as allotment is liable to be cancelled and the deposits Rs.5000/- + Rs.107225 = Rs.1,12,225/- made by you, already stands forfeited on dated 16.2.2016 by the competent authority of the Board and remaining amount of Rs.2145/- deposited by you on dated 3.3.2015 is to be forfeited. The clauses mentioned in this para are reproduced as under:

- a) **Clause No 10 of the declaration of application form:-** "That the above information is true to the best of my knowledge and belief and nothing has been concealed therein. If the information furnished by me in the application form or furnished later on at any stage is found to be incorrect/false, the Board shall have the right to cancel the

registration/allotment and to forfeit the entire amount paid in addition to the penal consequences under the law

- b) Clause No.IX of the Brochure of the Scheme of Dr.Ambedkar Awas Yozna : "If it is found at any stage that the applicant has furnished any incorrect or false information or suppressed any material facts in the Application Form for registration or later on, which makes him/her ineligible, the registration as well as allotment of dwelling unit, if made, shall be cancelled and the total deposits made till date shall be liable to be forfeited. The application shall also be liable to penal consequences under the Law."
- c) Clause No.20 of the allotment letter:- "if the allotment is cancelled in the event of the affidavit filed in the prescribed form alongwith the application or at the time of allotment with regard to the eligibility being found false at any stage, the Board would in addition to the cancellation of your registration with the Board and the allotment of the Dwelling Unit, forfeit the deposits received with the application and all the payments made to the Board thereafter in addition to the penal consequences under the law."

And whereas an opportunity of hearing was given on 13.3.2020 but none appeared nor any intimation received. However, as per record during hearing before the then Chief Executive Officer on 16.2.2016, you have admitted of having allotted another H.No.1789 at Mauli Jagran Chandigarh under 3187 ORT scheme.

Therefore, I, Chief Executive Officer, Chandigarh Housing Board being the Competent Authority have been left with no option but to cancel the registration and allotment of Dwelling Unit No 6772-A, Sector 56, Chandigarh. I further order to forfeit remaining amount Rs.2,145/- as per record besides already forfeited Rs.1,12,225/- on dated 16.2.2016.




