In this regard, it is informed that during the survey dt. 4.3.2020 the following fresh constructions undertaken in the subject cited DU were observed for which no permission had been sought from the Board:-

1. RCC Slab constructed over window of kitchen
2. Additional door opened towards staircase.
3. Chajja constructed at front side

A Challan No.01/38 dt. 4.3.2020 was issued and further due to non-compliance of the same a Notice-cum- Demolition Order was issued vide No.607 dt. 11.3.2020. Since before undertaking fresh constructions, approval from the Board should have been solicited as per order No.59 dt. 15.2.2019 but even till date no proposal has been submitted by you to the Board.

In view of above, you are requested to remove the violations and submit the proposal of Need Based Changes within a week positively failing which further necessary action as per the demolition order shall be taken.
