You are requested to attend this office to complete agreement along with Non-judicial stamp paper worth Rs. 100/- only & attested copy of General Power of Attorney /Partnership deed, if any, for signing the contract agreement, within 7 days from the date of issue of this letter.

You are also advised to take the license under Sub Clause-12 of contract labour (regulation & abolition) Act-1970 from Assistant Labour Commissioner of the area before commencement of the work.

You are requested to start the work immediately and contact the SDE-IV for further instructions to execute the work. Please note that the time allowed for carrying out the work is **6 Months** as entered in the tender document which shall be reckoned from 18.03.2020 as the official date of commencement of this work.

As per provision of the contract the performance guarantee @ 5% (Five percent) of the tendered amount i.e. Rs 17,20,600/- (Rupees seventeen lacs twenty thousand six hundred only) has already been deposited by you, in this office.
