The item wise rates mentioned in the DNIT and % age quoted by you for the said Tender shall be a part of agreement, which shall be supplied to you after execution of agreement.



Further this allotment shall be strictly governed by all the terms & conditions laid down in the bid document and not limited to the following:-


1. The revised justified amount shall be worked out at the time of every bill with actual quantities which shall be regulated by special condition No. 1.31 of the DNIT/Bid Document.
