



(BID FOR AUCTION OF OLD PHOTOCOPIER MACHINE ON "AS IS WHERE IS BASIS")

1. The Auction process is open for all the citizen of India above 18 years of age:
2. In no case, bid less than the reserve price of Rs. 4,827/- shall be accepted.
3. Rates will be considered through auction only and is offered for sale on "AS IS WHERE IS BASIS" at CHB Office.
4. In case of any dispute the decision of Chief Executive Officer, CHB will be final.
5. Once the bid is placed, the highest bidder shall not be permitted to withdraw or surrender his bid on any ground, and in case, he does so, the EMD deposited by him / her / them shall stand forfeited.
6. The Chief Executive Officer, Chandigarh Housing Board, Chandigarh has absolute right to accept or reject any or all the offer(s) or adjourn/ postpone/ cancel the auction without assigning any reason thereof. The bidders are advised to go through the detailed terms and conditions before submitting their EMD amount for taking part in the auction. The intending bidder should register their name(s) with SDE-E-IV, CHB while depositing the EMD.
7. Every Bidder will have to deposit Rs. 500/- as Earnest money for taking part in the bid for the items. In case of successful bidder, it will be adjusted towards the bid amount. The earnest money of the unsuccessful shall be refunded after the bid.
8. The bidder shall improve their bid in multiple amount of Rs.500/-.
9. The successful bidder shall deposit the accepted bid amount along with Goods and Service Tax as applicable.
10. After receiving of signed copies of terms and conditions, PAN Card and Copy of Residential identity Proof Aadhar Card/ Passport/ voter ID card/ Driving License bidders are allowed to participate in auction.
11. As per provisions contained under Section 194 of Income Tax Act, 1961 TDS as Income Tax will be applicable as the case may be. All the statutory and non-statutory dues, taxes, rates, assessment charges, fees etc. owing to anybody. Act Govt. tax/Levy present as well as future shall be borne by the participant.
12. The Chandigarh Housing Board reserves the right to withdraw the auction and to accept or reject the highest bid without assigning any reason.
13. Successful bidder shall deposit an amount equal to 25% of Bid amount at fall of Hammer and the balance 75% of the quoted price on or before 15th day of sale or within such extended period as agreed upon in writing by and solely at the discretion of the Authorized Officer. In case of default in payment by the successful bidder, the amount already deposited by the offer shall be liable to be forfeited and items shall be put to re-auction and the defaulting bidder shall have no claim/right in respect of amount.

14. In the event of any dispute or difference arising out of this bid, the same shall be referred to the sole Arbitrator appointed by the Chairman, Chandigarh Housing Board. The award of the Arbitrator shall be final and binding on the bidders.
15. It shall be the responsibility of the bidders to inspect and satisfy themselves about the asset and specification before submitting the bid. The inspection of items put up for auction will be permitted to interested bidders at CHB office on any working day between 10:00 AM to 4:00 PM except Saturday, Sunday and other gazetted holiday with prior appointment with SDE-E-IV, CHB (Mobile No 9815912570).
16. If the bidder does not remove the Photocopier Machine from the site within three working days from the date of receipt of full bid money, EE can confiscate the balance materials lying at site.
17. The Bidder shall be responsible for protecting the property of the CHB at the time of lifting of Photocopier Machine and he shall be liable to pay in case to damage, if any. The damage will be assessed by Engineer-in- Charge.
