



Subject: - Clarification regarding reimbursement of room rent charges for indoor treatment taken in Govt./ Private Hospitals.

I am directed to invite your kind attention to Chandigarh Administration Finance Department letter No.99/1/04-UTFII(12)/2009/4229 dated 22.06.2009 wherein it was clarified that in view of instructions of Punjab Govt. issued vide letter No.12/193/94-5HB-5/5251-54 dated 13.02.1995 giving freedom to the employees/ pensioners to get treatment from any private hospital in the country, the claims are to be considered by the Health Department at approved rates i.e. AIIMS/ PGI/ Govt. Rates and no permission is required from Health Department before getting the treatment from private hospitals.

This Administration has been receiving references from various Departments regarding clarification of rates of reimbursement of room rent charges on account of treatment taken in Govt./ Pvt. Hospitals by various category of Government employees/ pensioners/ dependents. The matter has been considered in consultation with the Director Health & Family Welfare, Union Territory, Chandigarh and it has been decided that reimbursement upto Rs.1500/- per day of room rent may be allowed to the eligible Chandigarh Administration employees/ pensioners and their dependents, for indoor treatment taken from Govt./ Pvt. Hospitals as per PGIMER rates, as amended from time to time.

The above instructions may be brought to the notice of all concerned for compliance.
