#### **ORDER**

NO. 35

Whereas the Chief Administrator, UT, Chandigarh in exercise of powers under first provision in sub rule (3) of Rule 9 of the Chandigarh (Sale of Sites and Buildings) Rules, 1960, Sub Rule (11) of Rule 17 of the Chandigarh Lease Hold of Sites and Buildings Rules 1973 and Sub Rule (i) of Rule 9 of the Chandigarh Estate Rules, 2007, and all other powers enabling him in this behalf, with the prior approval of the Administrator, Union Territory, Chandigarh, issued the orders with the directions regarding certain relaxations in the use of Residential buildings, in public interest for allowing Paying Guest Residential Accommodation (PGRA), keeping in view the norms of urban planning and the requirements of the citizens in residential areas of Union Territory of Chandigarh, vide order endst. No. 23/3/41-UTFI(3)-2006/5468-70 dated 05.09.2006, further amended vide no. 23/3/41-UTFI(3)-2007/398-399 dated 19.01.2007 and endst. no. 23/3/41-UTFI(3)-2020/4290-92 dated 11.03.2020.

Whereas, as resolved by Chandigarh Housing Board, in its 421st meeting held on 06.08.2020, vide agenda item no.421.4.4, Chandigarh Administration, Chandigarh, was requested vide letter dated 19.08.2020 to convey approval to the Draft paying Guest Residential Accommodation (PGRA) of CHB., to allow licensed Paying Guests in more houses to discourage unauthorized paying Guest Residential accommodation (PGRA).

Whereas, Principal Secretary Housing, Chandigarh Administration, vide letter no. 11/7/249-UTFI(6)-2020/2052 dated 22.02.2021, with the approval of the Advisor to the Administrator, UT, Chandigarh, clarified that the existing Paying Guest Policy of the Administration issued in 2006 by the Chief Administrator, UT, Chandigarh, further amended in 2007 and 2020 is also applicable in residential areas/dwelling units of Chandigarh Housing Board subject to fulfillment of requisite conditions laid down in the policy issued by the Administration in 2006 and further amended in the year 2007 and 2020.

Therefore, the existing Paying Guest Policy of the Chandigarh Administration issued in 2006 by the Chief Administrator, UT, Chandigarh, further amended in 2007 and 2020, is hereby allowed to be applicable for residential areas/dwelling units of Chandigarh Housing Board subject to fulfillment of requisite conditions laid down in the policy issued by the Administration in 2006 and further amended in the year 2007 and 2020.
