
Subject: Notice under Section 15 of the Capital of Punjab (Development & Regulation Act), 1952 for alteration/demolition of unauthorized construction.

1. Casting RCC slab adjoining back balcony on passage of garages.

Subject: Notice under Section 15 of the Capital of Punjab (Development & Regulation Act), 1952 for alteration/demolition of unauthorized construction.

Refer to the Challan No. 01/64 dated -01.04.2021 about the following fresh constructions/ alterations in your dwelling unit Chandigarh Building Rules (Urban)-2017:-

1. Constructing mummy and parapet at 3rd floor.
2. Constructing stair from 2nd and 3rd floor.
3. 2nd floor fully covered.
4. Constructing room on 1st floor at rear terrace.
5. Parapet constructing on top of rear terrace at 2nd floor.
