The Chandigarh Administration, vide order no. EO-61871/F-4369/FII-(6)/2021/4640 dated 27.04.2021, has appointed the undersigned as the Nodal Officer for managing medical oxygen supply in UT, Chandigarh.

- Further the Chandigarh Administration vide order no. PS/AA/562 dated 06.05.2021 had assigned the charge to Shri Jagjit Singh, PCS for coordinating with all private hospitals located in Chandigarh regarding their availability of beds and supply of medical oxygen.
- 3. Considering acute shortage of medical oxygen, it was decided to rationalize distribution of oxygen and fix a daily quota for each of the Private Hospital. During the process, it was observed that one of the Private Hospital 'Eden Hospital' was consuming abnormal quantity of about 350 or 400 cylinders per day while another hospital of almost same capacity was consuming about 90 cylinders only.
- 4. In view of above, it has been decided that:
 - i. A Committee chaired Shri Jagjit Singh, PCS will conduct an inquiry about the abnormal consumption pattern of medical oxygen cylinders by Eden Critical Care Hospital' for the period from 01.04.2021 onwards. Dr. Manjit Singh, GMSH-16 and Dr. Manpreet Singh, GMCH-32 will be member of the Committee. The committee to submit its report within 15 days.

ii. Shri Jagjit Singh, PCS along with Dr. Manjit Singh, GMSH-16 and Dr. Manpreet Singh, GMCH-32 to visit all the Private hospitals located in Chandigarh during next week. The purpose of the visit will be to educate and sensitize them for optimum utilization of oxygen, which is a precious commodity.

iii. Dr. Manjit Singh, GMSH-16 and Dr. Manpreet Singh, GMCH-32 to also visit the Government Hospitals Chandigarh during next 15 days to educate and sensitize them for optimum utilization of oxygen
