Sir,

It is to bring in your kind notice that Chandigarh has been allocated 20 MT medical oxygen quota by the Government of India. Since there is no cylinder refilling plant in Chandigarh, all the hospitals (both Government and Private) are dependent upon the private refilling vendors located in nearby areas like Derabassi and Rajpura in Punjab.

Presently, there is serious crisis in the Government and private hospitals in Chandigarh due to shortage of refilled medical oxygen cylinders (both B' type & 'D' type). To avoid any untoward incident and save the precious human lives, it is requested that:

- 1.. The medical oxygen quota out of the quota of UT, Chandigarh may be allowed to be decanted at M/S Jalan Gases, Rajpura, District Patiala, Punjab for the purpose of refilling of medical oxygen cylinders.
- 2. M/S Chandigarh Gases, Plot 67, Industrial Area Phase I, Chandigarh, 160002 may kindly be permitted to get the cylinders refilled from M/S Jalan Gases, Rajpura, District Patiala, Punjab and transport them back to the Government & private hospitals in Chandigarh.
