Subject: **Security at the Premises of M/S Super Agencies**

Considering the acute shortage of medical oxygen in the UT, Chandigarh, the undersigned has issued an order No.CEO-CHB/2021/PA/83 dated 06.05.2021 that the oxygen generation plants located within the UT, Chandigarh will cater to the need of health institutions within the Chandigarh only (copy enclosed). To ensure compliance of these instructions, some officers of the Chandigarh Administration have also been stationed at the premises of M/S Super Agencies, 40 M.W. Industrial Area-I, Chandigarh-160002. Today vide order No. CEO-CHB/2021/PA/85 dated 07.05.2021, Sh. Rajeev Singla, Chief Engineer, Chandigarh Housing Board (Phone:9876017611) has been assigned the responsibility to ensure compliance of the instructions given to the oxygen generation plants (copy enclosed).

It has been reported that yesterday (06.05.2021) evening some of the influential persons, who are not eligible to get their oxygen cylinders refilled, pressurised the officials of the oxygen generation plant of M/S Super Agencies, 40 M.W. Industrial Area-I, Chandigarh-160002. Considering that any shortage of medical oxygen to the hospitals in UT, Chandigarh may lead to serious crisis and loss of human lives, it is requested that appropriate security may be put in place at the premises of the M/S Super Agencies, 40 M.W. Industrial Area-I, Chandigarh-160002.

**ORDER**

The Chandigarh Administration, vide order no. EO-61871/F-4369/FII-(6)/2021/4640 dated 27.04.2021, has appointed the undersigned as Nodal Officer for managing medical oxygen supply in UT, Chandigarh.

2. The Ministry of Health and Family Welfare, Government of India has fixed the daily quota of 20 MT of medical oxygen for UT, Chandigarh from M/s INOX Barotiwala. This medical oxygen is being utilized for GMCH-32, GMSH-16 and the COVID Hospital at Sector-48, Chandigarh. Further the Private Health Care Institutions in the Chandigarh also require medical oxygen and they are mostly dependent upon medical oxygen in cylinders.

3. Vide order No. CEO-CHB/2021/PA/58 dated 29.04.2021, the following three Private Refilling Vendors are being provided sufficient quantity of medical oxygen, out of the 20 MT Quota of UT, for the purpose of re-filling medical oxygen cylinders of the HealthCare Institutions in Chandigarh (Both Government and Private):

4. Vide order no. No. CEO-CHB/2021/PA/70 dated: 04.05.2021, for better co-ordination and to ensure that the 20 MT quota of Oxygen is regularly supplied by M/s INOX to the three Government Hospitals (GMCH-32, GMSH-16 & Hospital-48) and also to each of the three Private Refilling Vendors, Shri Y.P. Batra, SDE(PH) and Shri Ashok Singla, AE(PH), Chandigarh Housing Board have been stationed at Barotiwala (Baddi), Himachal Pradesh.

6. Shri Jagjit Singh, PCS will co-ordinate with all the private health care institutions regarding supply of oxygen. He will ensure that there is no diversion/wastage of the medical oxygen.

7. Admission of patients in Mini COVID Care Centres will be regulated through Government Hospitals. Considering acute shortage of medical oxygen for the patients admitted in Government Hospitals, the Mini COVID Care Centres will make their own arrangements for oxygen either through cylinders or through oxygen concentrators. Till proper arrangements are made by them for Oxygen, they may cater to those patients only who do not require Oxygen.

8. Dr. Manjit Singh, Medical Officer GMSH-16 (9463488086) will be the overall incharge. With the assistance of these Nodal Persons/Officers and other concerned, he will co-ordinate with M/s INOX Barotiwala and will ensure that the daily 20 MT quota of medical oxygen is rationally distributed between GMCH-32, GMSH-16 and COVID Hospital, Sector 48. The remaining quantity, as decided Dr. Manjit Singh, to be provided by the M/s INOX Barotiwala directly to these three Private Refilling Vendors to re-fill the medical oxygen cylinders of Health Care Institutions within Chandigarh (Both in Government and Private and sector). The quantity of medical oxygen provided to these Private Refilling Vendors and the quantity of oxygen supplied by them to Health Care Institutions of Chandigarh to be regularly monitored by Dr. Manjit Singh, Medical Officer. Shri Pawan Kumar, SDE (PH) (Phone:7508185459, 9501029051) will help him in this regard.

9. Shri Sorabh Kumar Arora, PCS with the assistance of Dr. Manjit Singh, Medical Officer will supervise overall supply, distribution and consumption of medical Oxygen in UT Chandigarh. He may prepare a back-up plan to get some supply of medical Oxygen from Punjab & Haryana to handle any crisis at eleventh hours. The authorities of other states may be assured that in such a situation, the oxygen provided by them will be replenished from the next supply of medical Oxygen from the UT Quota.

10. As decided by the UT Administration, vide letter no. PA/PSH/23 dated 05.05.2021, the tankers carrying medical Oxygen will be provided escort by the Chandigarh Police to reduce the travel time and avoid any untoward incident. Sh. Dalip Rattan, DSP ( Lines ) ( 7087116990 ) is the Nodal Police Officer for this purpose. Sh. Dalbir Singh Inspector (Lines) (9417008173, 7087239004) is assisting Sh. Dalip Rattan in this regard.

11. All the Oxygen Generators within the UT Chandigarh are directed to cater to the need of Health Institutions within the Chandigarh Only. Further they will ensure that daily refilling of Oxygen Cylinders is regulated as under:

- o Industrial Cylinder will not be accepted for refilling. The cylinders which are prescribed for medical oxygen gas should only be used for this purpose.
- o The cylinders should be hydraulically tested as per the prescribed guidelines/standards to avoid any mishap during the process of refilling and transportation.
- o Refilling Quota of medical Oxygen Cylinders for each of the private health care institution will be decided by Shri Jagjit Singh, PCS. To take care delay in supply chain, the requirement of cylinders should be indicated to the Oxygen Generators/Private Re-filling Vendors, before a prescribed time daily

5. Shri Rajeev Singla, Chief Engineer, Chandigarh Housing Board is assigned the responsibility to monitor the three Private Refilling Vendors and also the Oxygen Generators in UT. He will ensure that:

- The liquid oxygen provided to the Private Refilling Vendors, out of the UT Quota, is utilized to refill the medical oxygen cylinders Health Care Institutions within Chandigarh (both in Government and Private sector) only and there is no diversion.
- All the Oxygen Generators Plants located within the UT Chandigarh to cater to the need of Health Institutions within the Chandigarh Only.
- Re-filling of medical oxygen cylinders is being done on the same rates which has been approved for the GMCH-32, as per the order No. CEO-CHB/2021/PA/58 dated 29.04.2021.

7. **To ensure compliance of the instructions at Para-6 above, required number of officers/officials need to be stationed at the premises of the three Private Refilling Vendors and also at the premises of Oxygen Generation Plants to ensure that the process of re-filling/transportation is smooth and there is no delay/wastage/diversion during the process.** He may take the assistance of all the officers/officials, under his control, in the Engineering Wing of CHB. Further, in consultation with Secretary CHB, he may also take the assistance of officers/officials posted in other Wings/Branches of CHB.
