It is also pertinent to mention here that Sh. Gurmukh Singh, father of Smt. Gurmail Kaur has been died on 04.03.2008 and Smt. Surjeet Kaur, mother of Smt. Gurmail Kaur has also been died on 19.04.2012.

Further, as per the directions of Hon'ble District Court, UT, Chandigarh dated 24.11.2017 in CS/1465/2017, the said five sisters are declared the Class 1 legal heirs of Late Smt. Gurmail Kaur and **Smt. Balwinder Kaur D/o Late Sh. Gurmukh Singh W/o Sh. Amitpal Singh** entitled to inherit the estate of Gurmail Kaur.

In case, if anyone has any objection regarding their claim/rights/title/interest in the above mentioned dwelling unit which is to be allotted by
