ORDER

It has been observed that some of the officers/officials deputed on COVID/BLO related duties are not attending their assigned work in the Chandigarh Housing Board. Few of them have shown same attitude of avoiding CHB work in the past also whenever some additional assignment was given to them and hence they have not improved despite memos/warnings issued previously.

Considering that the COVID cases in the City being almost negligible now and many priority projects of CHB are to be completed within 100 days time lines and also the visiting public is complaining about delay in their work, all the CHB officers/officials need to also attend the duties assigned in the Chandigarh Housing Board.

In view of above all the CHB officers/officials deputed on COVID/BLO related duties are directed to also attend their assigned work in the Chandigarh Housing Board.
