You are also advised to take the License under sub class-12 of contract Labour (regulation & abolition) Act. 1970, from Assistant Labour Commissioner of the

Area before commencement of the work including any other permission required from the State as per statutory requirements.

You are requested to start the work immediately and contact the SDE-E-I, CHB for further instructions to execute the work. Please note that the time allowed for carrying out the work is **04 months (Four Months)** as entered in the tender document which shall be reckoned from 25.08.2021 as the official date of commencement of this work.
