- 1. The e-Auction process is open for all the citizen of India above 18 years of age after registering their name(s) at <u>http://www.eauction.gov.in</u>.
- 2. Bidders must have digital signature certificate (DSC) Class-II. E-auction without digital signature will not be accepted by the e-Auction portal.
- 3. Before submitting their Bids and taking part in the e-auction, the bidders are advised to go through the detailed Terms and conditions of e-auction available on the web portal at http://www.eauction.gov.in.


