Commissioner of the Area before commencement of the work including any other permission required from the State as per statutory requirements.

You are requested to contact the SDE-E-I, CHB for further instructions to execute the work. Please note that the time allowed for carrying out the work is **04 months (Four months)** as entered in the tender document which shall be reckoned from **03.01.2022** as the official date of commencement of this work.
