- 1. The c-Auction process is open for all the citizen of India above 18 years of age after registering their name(s) at <u>http://www.cauction.gov.in</u>.
- 2. Bidders must have digital signature certificate (DSC) Class-II. E-auction without digital signature will not be accepted by the e-Auction portal.
- 3. Before submitting their Bids and taking part in the c-auction, the bidders are advised to go through the detailed Terms and conditions of e-auction available on the web portal at <u>http://www.eauction.gov.in</u>.
- 4. All the Disposal of surplus (unserviceable) i.e. RCC pipe, RCC Collar and Spun Yarn lying in CHB central store offered for sale is on "AS IS WHERE IS BASIS". It is expressly understood that the bidder has fully satisfied himself regarding the quality, quantity & condition of auction able material before bidding. It is presumed that the bidder is fully aware of lot put to auction and no complaint whatsoever will be entertained after the bid is made.
- 5. Chandigarh Housing Board reserves the right to withdraw e-Auction without assigning any reason at any stage of e-Auction process.
- 6. Rates will be considered through e-Auction only. The rates of all the disposable surplus (unserviceable) i.e. RCC pipe, RCC Collar and Spun Yarn lying in CHB Central Store, Industrial Area, Phase-I, Chandigarh on 'As is where is Basis' be quoted as one lot. - 7. In no case, bid less than the reserve price shall be accepted.
