1. Your tender referred above for the work cited as subject has been accepted by the Chief Engineer, CHB vide R.D. No. 2384 dated 06.10.2021 at your tendered amount of Rs.37,33,173/- (Rupees thirty seven lakh thirty three thousand one hundred and seventy three only) which is 33.70% below the DNIT amount of Rs.56,30,729/- (Rupees fifty six lakh thirty thousand seven hundred and twenty nine only) and 23.82% below the justified Amount of Rs. 49,00,164/- (Rupees forty nine lakh one hundred and sixty four only).

2. A statement in respect of your quoted rates vis a vis Justified Rates indicating the total amount respectively may be obtained from the office of undersigned.

3. The item wise Rates mentioned in the DNIT and %age quoted/amended by you for the said Tender, shall be a part of Agreement, which shall be supplied to you after execution of Agreement.

4. You will have to execute agreement with the undersigned. You are requested to attend this office to complete agreement along with Non-judicial stamp paper worth Rs. 100/- only & attested copy of General Power of Attorney /Partnership deed, if any, for signing the contract agreement, within 7 days from the date of issue of this letter.

5. You are also advised to take the license under Sub Clause-12 of contract labour (regulation & abolition) Act-1970 from Assistant Labour Commissioner © of the area before commencement of the work.

6. You are requested to start the work w.e.f 05.02.2022 and contact the SDE-VIII, CHB for further instructions to execute the work. Please note that the time allowed for carrying out the work is 2 months as entered in the tender document which shall be reckoned from **05.02.2022** as the official date of commencement of this work.

Further this allotment shall be governed by the following

1. Tended amount of Rs.37,33,173/- (Rupees thirty seven lakh thirty three thousand one hundred and seventy three only) is 33.70% below the DNIT amount of Rs.56,30,729/- (Rupees fifty six lakh thirty thousand seven hundred and twenty nine only) and 23.82% below the justified Amount of Rs. 49,00,164/- (Rupees forty nine lakh one hundred and sixty four only).
2. Revised justified amount (X) on the same parameters (including correction, if any required w.r.t. the original tender submitted /DNIT taken into account for arriving at justified amount) as worked out at the time of award of work shall be worked out at the time of completion of work with actual quantities.
3. The agency will give suitable rebate in case the actual % age of the actual amount of work (excluding escalation) at time of completion of work above (X) increases from the original %age (O) i.e. **-23.82%** above the justified amount (for example if the 'actual % age above is **-22.82%** then the agency will give suitable rebate to bring the actual % age to above **-23.82%**) However, if 'actual % age above' (X) decreases from the 'original % age (O)' i.e. **-24.82%** above then no relief or extra payment shall be made (for example if the actual % age above is **-24.82%** then no extra payment to bring the % age above at par with the said **-23.82%** above shall be made).
4. The work shall be executed by the agency strictly as per tender documents complying with all the conditions mentioned therein & to the entire satisfaction of the Engineer In charge.
5. Any error/omission in this letter will be dealt as per tender submitted/opened on **12.07.2021**, financial bid opened on **09.08.2021** and as per approved tender document.
