Please note that the time allowed for carrying out the work as entered in the tender document is **Two months** which shall be reckoned from **07.02.2022** as the official date of commencement of this contract.

As per provision of the contract the performance guarantee in the shape of F.D. of Rs.1,28,000/- (Rupees One lac twenty eight thousand Only) has already been deposited by you, in this office.

Further, this allotment shall be strictly governed by all the Terms & Conditions laid down in the Bid Document and not limited to that any error/omission in this letter will be dealt as per tender submitted on 28.01.2022 & Financial Bid opened on 31.1.2022 and as per approved Tender Document.


