Please note that the time allowed for carrying out the work as entered in the tender document is **One month** which shall be reckoned from **25.04.2022** as the official date of commencement of this contract.

As per provision of the contract the performance guarantee in the shape of F.D. of Rs.16,650/- (Rupees Sixteen thousand six hundred fifty only) has already been deposited by you, in this office.
