You are requested to start the work immediately and contact the SDE-E-IV, CHB for further instructions to execute the work. Please note that the time allowed for carrying out the work is **06 months** (Six Months) as entered in the tender document which shall be reckoned from **20.05.2022** as the official date of commencement of this work.
