General Terms & Conditions for Disposal of Condemned Vehicle Maruti Suzuki Gypsy Model-08/2007 at Chandigarh Housing Board Chandigarh on 'AS IS WHERE IS BASIS'

1. The e-Auction process is open for all the citizen of India above 18 years of age after registering their name(s) at <http://www.eauction.gov.in>.
2. Bidders must have digital signature certificate (DSC) Class-II. e-Auction without digital signature will not be accepted by the e-Auction portal.
3. The bidders are advised to go through the detailed Terms & Conditions of e-Auction available on the web portal at <https://www.eauction.gov.in> before submitting their bids and taking part in the e-Auction.
4. **Maruti Suzuki Gypsy Model-08/2007**; offered for sale is on '**AS IS WHERE IS BASIS**'. It is expressly understood that the bidder has fully satisfied himself regarding the quality, quantity & condition of auctionable material before bidding. It is presumed that the bidder is fully aware of lot put to auction and no complaint whatsoever will be entertained after the bid is made.
5. Chandigarh Housing Board reserves the right to withdraw e-Auction without assigning any reason at any stage of e-Auction process.
6. Rates will be considered through e-Auction only. The bid shall remain valid for a period of **75 days** from the e-Auction date.
7. In no case, bid less than the reserve price shall be accepted.
8. Prevailing Goods & Service Tax (GST) will be charged extra. The successful bidder has to pay the tax & receipt of the same shall be produced within stipulated time.
9. The Successful e-Bidder shall deposit the Bid Amount quoted in the e-Bid alongwith Goods and Services Tax as applicable (presently 18% G.S.T is chargeable).
10. As per provisions contained under Section 206 (c) of the Income Tax Act, 1961, Income Tax as applicable of the amount will be payable by the successful bidders to CHB and further paid to Income tax Office.
11. All the statutory and non-statutory dues, taxes, rates, assessment charges, fees etc. owing to anybody. Act Govt. tax/Levy present as well as future shall be borne by the e-Bidder / participant.
12. The registration window will remain open from _____ to _____ (up to 3 P.M. on last day) in all the days during the e-Auction process. The interested bidder has to submit their Bid documents/EMD/Registration before closure of deadline. After going through the registration process (one-time) and generating user ID & Password, bidders shall be eligible for participating in the e-Auction process



subject to due verification (of the documents) and/or approval of the service provider i.e. NIC. The e-Auction of Disposal of Maruti Gypsy Registration No. CH01G1-1857 at Chandigarh Housing Board Chandigarh on 'As is where is basis' would be conducted strictly within the scheduled date and time by way of bidding amongst the bidders and **the bidder shall improve their offer in multiples of an amount i.e. Rs.1000/- mentioned under the column "Bid-increase amount"**.

13. Bidders holding valid User ID/Password and confirmed payment of **EMD amounting to Rs.8000/- through NEFT/RTGS** shall be eligible for participating in the e-Auction process. The payment would be made through RTGS/NEFT of the following account of the Chairman, Chandigarh Housing Board, and Chandigarh.

14. After receiving of PAN, signed copies of terms and conditions and scanned image of RTGS/NEFT so uploaded, bidder are allowed to participate in online e-Auction on the web portal <http://www.eauction.gov.in>.
15. In case of e-Bidding at the last moment, e-Bidders are requested to make all the necessary arrangements/alternatives such as power supply backup etc. so that they are able to participate in the e-Auction and submit the bid in time i.e. on or before the bid submission end time.
16. In case any e-Bid is placed in the last five minutes of the closing time of e-Auction, the closing time will be automatically extended for 10 minutes (subject to unlimited number of extensions of 10 minutes each, every time a bid is submitted). The e-Bidder who submits the highest e-Bid on closure of e-Auction process shall be declared as a successful bidder and a communication to that effect will be issued by the Authorized Officer within **07 days**.
17. Once the bid is placed, the highest bidder shall not be permitted to withdraw or surrender his bid on any ground, and in case, he does so, the EMD deposited by him / her / them shall stand forfeited in full.
18. Earnest Money Deposit (EMD) of the successful bidder shall be retained towards part sale consideration and the EMD of unsuccessful bidders shall be refunded (without interest) after finalization of e-Auction process. The Earnest Money Deposit shall not bear any interest.
19. The successful bidder shall have to deposit **25% of sale price quoted in e-Bid**, adjusting the EMD already paid, within **three days** after the



acceptance of bid price by the Authorized Officer and the **balance 75% of the sale price on or before 15th day of acceptance of bid** or within such extended period as agreed upon in writing by and solely at the discretion of the Authorized Officer made through RTGS/NEFT in CHB Account given in **clause 13** above. **In case of successful bidders backs out, earnest money/ amount already deposited shall be forfeited and lot/items shall be put to re-auction and the defaulting bidder shall have no claim/right in respect of amount and the bidder will be black listed for participating in any future e-Auction/contract as per Chandigarh Administration Finance Department Notification No. 1927-F&PO (3)-2009/1170, dated 27.02.2009.**

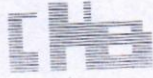
20. A person can e-Bid on behalf of another person only if he discloses the name of such person and in case of a company, firm/institute/autonomous bodies or members of Joint Hindu Family etc. as the case may be/shall be given immediately after the e-Bid closed/accepted. No e-Bid shall be accepted in the name of a firm or a company or on behalf of any other person (s) unless the names of all other persons giving the offer are given with the complete specification of shares and the person making the e-Bid produces a valid and legal power of attorney authorizing him to e-Bid on others behalf.
21. No addition in the name of e-Bidder shall be allowed after the acceptance of e-Bid. The name of the person in whose behalf e-Bid has been accepted shall be made known to the e-Bidder at that very time and no alteration in the name shall be allowed, if the e-Bid is given on behalf of a firm or company the number of share and each share holder of exact share or each partner, co-lessee or joint lessee shall be made known by the e-Bidder immediately and no subsequent addition or alteration of number of shares declared at the time of e-Bid shall be allowed.
22. The Chairman, Chandigarh Housing Board, Chandigarh/Authorized Officer has absolute right to accept or reject any or all the offer(s) or adjourn/postpone/cancel the e-Auction without assigning any reason thereof.
23. In the event of any dispute or difference arising out of this bid, the same shall be referred to the sole Arbitrator appointed by the Chairman, Chandigarh Housing Board. The award of the Arbitrator shall be final and binding on the bidders.
24. The successful bidders will have to lift the Maruti Gypsy Registration No. CH01G1-1857 and clear the site properly within stipulated time of **fifteen days from the date of receipt of full bid money** to the satisfaction of the engineer-in-charge. If the bidder does not remove the **Maruti Suzuki Gypsy** from the site within **prescribed days**, penalty of Rs.1000/- per day plus GST for each day of delay upto next 30 days shall be levied. After that EE



- can confiscate the balance materials, if any lying at site. Prevailing safety norms has to be followed.
25. The Bidder shall be responsible for protecting the property of the CHB at the time of lifting of **Maruti Suzuki Gypsy**. During lifting of **Maruti Suzuki Gypsy** if any damage occurred will be compensated/ rectified by the successful bidder. The damage will be assessed by Engineer-in- Charge.
