2. Revised justified amount (X) on the same parameters (including correction, if any required w.r.t. the original tender submitted /DNIT taken into account for arriving at justified amount) as worked out at the time of award of work shall be worked out at the time of completion of work with actual quantities.

3. The agency will give suitable rebate in case the actual % age of the actual amount of work (excluding escalation) at time of completion of work above (X) increases from the original %age (O) i.e **4.70%** above the justified amount (for example if the 'actual %age above is **5.70%**) then the agency will give suitable rebate to bring the actual % age above as **4.70%** However, if 'actual % age above' (X) decreases from the 'original % age (O)' i.e. **4.70%** above then no relief or extra payment shall be made (for example if the actual % age above is **3.70%** then no extra payment to bring the % age above at par with the said **4.70%** above shall be made).
