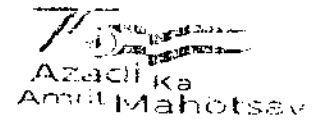

The item wise rates mentioned in the DNIT and % age quoted by you for the said Tender shall be a part of agreement, which shall be supplied to you after execution of agreement.



You are also advised to take the License under sub class-12 of contract Labour (regulation & abolition) Act 1970, from Assistant Labour Commissioner of the Area before commencement of the work including any other permission required from the State as per statutory requirements.

You are requested to start the work immediately and contact the SDE-E-I, CHB for further instructions to execute the work. Please note that the time allowed for carrying out the work is **30 days (One Month)** as entered in the tender document which shall be reckoned from **22.07.2022** as the official date of commencement of this work.

Further this allotment shall be strictly governed by all the terms & conditions laid down in the bid document and not limited to the following:-
