3. Performance Security/ Deposit Receipt Sl. No. 646464 dated 13.07.2022 amounting to Rs. 20,000/- issued by Canara Bank, Sector 44 C, Chandigarh submitted by you in Div. IV, CHB and verified by same bank on 15.07.2022.

1. Your tender referred above for the work cited as subject has been accepted by the Superintending Engineer-II, CHB vide R.D. No. P-610794 dated 11.07.2022 at your tendered amount of **Rs.6,61,104/-** (Rupees Six lakh sixty one thousand one hundred & four only) which is 5.00 % below the DNIT amount of Rs.6,95,899/- (Rupees Six lakh ninety five thousand eight hundred and ninety nine only) and 1.87 % below the justified Amount of Rs.6,73,695/- (Rupees Six lakh seventy three thousand six hundred and ninety five only).

2. A statement in respect of your quoted rates vis a vis Justified Rates indicating the total amount respectively may be obtained from the office of undersigned.

3. The item wise Rates mentioned in the DNIT and %age quoted/amended by you for the said Tender, shall be a part of Agreement, which shall be supplied to you after execution of Agreement.

4. You will have to execute agreement with the undersigned. You are requested to attend this office to complete agreement along with Non-judicial stamp paper worth Rs. 100/- only & attested copy of General Power of Attorney /Partnership deed, if any, for signing the contract agreement, within 7 days from the date of issue of this letter.

5. You are also advised to take the license under Sub Clause-12 of contract labour (regulation & abolition) Act-1970 from Assistant Labour Commissioner of the area before commencement of the work.

6. You are requested to start the work immediately and contact the SDE-IV for further instructions to execute the work.

7. Please note that the time allowed for carrying out the work is 30 Days as entered in the tender document which shall be reckoned from **25.07.2022** as the official date of commencement of this work.

**Further this allotment shall be governed by the following**

1. Tendered amount of **Rs.6,61,104/-** (Rupees Six lakh sixty one thousand one hundred & four only) is 5.00 % below the DNIT amount of Rs.6,95,899/- (Rupees Six lakh ninety five thousand eight hundred and ninety nine only) and 1.87 % below the justified Amount of Rs.6,73,695/- (Rupees Six lakh seventy three thousand six hundred and ninety five only).
2. Revised justified amount (X) on the same parameters (including correction, if any required w.r.t. the original tender submitted /DNIT taken into account for arriving at justified amount) as worked out at the time of award of work shall be worked out at the time of completion of work with actual quantities.
3. The agency will give suitable rebate in case the actual % age of the actual amount of work (excluding escalation) at time of completion of work above (X) increases from the original %age (O) i.e **1.87%** below the justified amount (for example if the 'actual %age above is (-) **0.87 %** then the agency will give suitable rebate to bring the actual % age above as (-) **1.87%** However, if 'actual % age above' (X) decreases from the 'original % age (O)' i.e. **1.87%** below then no relief or extra payment shall be made (for example if the actual % age above is (-) **2.87 %** then no extra payment to bring the % age below at par with the said **1.87%** below shall be made).
4. The work shall be executed by the agency strictly as per tender documents complying with all the conditions mentioned therein & to the entire satisfaction of the Engineer In charge.
5. Any error/omission in this letter will be dealt as per tender submitted/opened on **28.06.2022**, financial bid opened on **30.06.2022** and as per approved tender document.
