The item wise rates mentioned in the DNIT and % age quoted by you for the said Tender shall be a part of agreement, which shall be supplied to you after execution of agreement.



You are requested to start the work immediately and contact the SDE-E-I, CHB for further instructions to execute the work. Please note that the time allowed for carrying out the work is **02 Months (Two Months)** as entered in the tender document which shall be reckoned from 12.12.2022 as the official date of commencement of this work.


