**ORDER**


1. WHEREAS, in the Court of Jaibir Singh, Special Judge/Additional Sessions Judge, Chandigarh, the Hon'ble Judge found Sh Rajesh Kumar, Sr. Asstt. guilty for the commission of offences punishable under Section 7 and 13(2) of Prevention of Corruption Act and convicted thereunder and ordered to take the custody and to produce on 16.12.2022 for hearing arguments on quantum of sentence vide judgment order dated 15.12.2022.
2. AND WHEREAS, another judgment order on quantum of sentence was passed by Hon'ble Court on 16.12.2022 and Sh Rajesh Kumar was ordered to undergo sentence as follows: -

Offence/U/s	Imprisonment	Fine	In default of fine imprisonment
7 of Prevention of Corruption Act	Rigorous Imprisonment for 5 years	Rs 25,000/-	R.I. of one year
13 (2) of Prevention of Corruption Act	Rigorous Imprisonment for 7 years	Rs 50,000/-	R.I. of one year

Both the sentences shall run concurrently. The period of custody undergone by convict during investigation and trial of this case be set off against the substantive sentence awarded to him.

3. NOW THEREFORE, the undersigned in exercise of the powers conferred under Rule 10 (2) (b) of the Central Civil Services (Classification, Control and Appeal) Rules, 1965, hereby place Sh. Rajesh Kumar, Sr. Asstt., Chandigarh Housing Board, under suspension w.e.f 15.12.2022 i.e. date of detention.
4. It is further ordered that during the period of suspension, the Headquarter of Sh. Rajesh Kumar, Sr. Asstt., Chandigarh Housing Board, shall be the office of the Secretary, Chandigarh Housing Board and he shall not leave the Headquarters without obtaining the prior permission of the undersigned.
