

In reference to your online e-auction bid upto 07.02.2023 for the work cited as subject, the bid has been accepted in favour of you on 24.02.2023 by the Competent Authority of CHB at your highest quoted bid amount of Rs.2,11,000/- (Rupees Two Lakh Eleven Thousand Only) + GST @18% (Rs.37,980/-) + TCS @1% (Rs.2,490/-). You are requested to start and accomplish the work like dismantling & removal of dismantled materials and clear the site properly within stipulated time of forty five days from the date of commencement of the work to the satisfaction of the engineer-in-charge. If you do not remove the material from the site within prescribed days, CHB can confiscate the balance materials lying at site. Prevailing safety norms has to be followed.
3. You shall be responsible for protecting the property of the CHB at the time of dismantling & lifting of material. During dismantling & lifting of the materials, if any damage occurs, the same will be compensated /rectified by you. The damage will be assessed by Engineer-in-charge.
4. You will abide by all the terms & conditions of e-auction documents.
5. Please note that the time allowed for carrying out the job as entered in the Bid Document are 45 days which shall be reckoned from 20.03.2023 as the official date of commencement of this work.
6. You are requested to contact the SDE-V, CHB for further instructions to execute the work.


