1. 4. In case of default in payment by you, the amount already deposited by you shall be liable to be forfeited and lot/items shall be put to re-auction and the defaulting bidder shall have no claim/right in respect of amount.
5. On receipt of the total bid amount, necessary letter to commence the work shall be issued by fixing the date of commencement.
6. Please also note that you would acquire lien on the auctioned materials after the payment of full bid money, and you will be responsible for any damage by way of pilferage, fire, or any natural calamity, and no claim on this account shall be entertained by CHB.
