- 1 The purchaser shall within the time frame given in DNT/Allotment letter, pay to the Engineer-in-Charge the total amount of tender/bided where upon he/they shall take possession of the surplus material lying in CHB Central Store Industrial Area Phase-I Chandigarh.

- 1.1 The tenderer/bidder whose tender/bid is accepted shall deposit @100% of bid amount (including GST and Income Tax after adjusting EMD) within 7 days of the award of the work. The amount of earnest money shall be released after clearance of site to the satisfaction of Engineer-in-Charge, otherwise shall get the site clear at risk and costs of contractor.
- 1.2 While quoting the rates the purchaser shall take into account the surplus (Un-serviceable) i.e. Spun Yarn lying in CHB Central Store, Industrial Area Phase-I, Chandigarh on "as is where is basis". The total amount quoted by the highest bidder shall be deposited online at State Bank of India, CHB Branch, Sector 9-D, Chandigarh Account No. 10413593032, IFSC code SBIN0010604 within seven days of the award of the work.
- 1.3 The material shall be lifted within One Month from the date of written instruction to start the work. In case of delay levy of Rs.3,000/-+GST per day delay shall be imposed and amount shall be adjusted from the Earnest Money.
- 1.4 To ensure effective enforcement of the rules and regulations relating to safety precautions the arrangements made by the contractor shall be to inspection by the Labour Officer or Engineer-in-Charge of the department or their representatives.
- 1.5 The tenderer shall visit and inspect the site and obtain all information on his own responsibility and at own cost, which may be necessary for the purpose of quoting and submitting the tender. - 1.8 Suitable safety arrangement should be provided as per CPWD Safety Code.
- 1.9 All the Disposal of surplus (Un-serviceable) i.e. Spun Yarn lying in CHB central store offered for sale is on "As is where is Basis". It is expressly understood that the bidder has fully satisfied himself regarding the quality, quantity & condition of surplus (un-serviceable) i.e. Spun Yarn before bidding.
