Reference orders dated 31.03.2023 passed by the Chairman, CHB on the above cited subject.

Whereas, The **Dwelling Unit No.2210-1, Category MIG, Sector 45-C, Chandigarh** was allotted on Hire Purchase Basis to Sh. Harcharan Singh Blahi s/o Sh. Sardar Singh vide Allotment Letter No. 627 dated 20.03.1989. The DU was transferred in the name of Smt. Ravinder Kaur w/o Sh. Manjinder Singh on the basis of Intestate Demise vide letter No. 25792 dated 08.07.2016. Thereafter, the DU was transferred in the name of Sh. Karamjit Singh s/o Late Sh. Bachan Singh and Mrs. Gurinder Kaur w/o Sh. Karamjit Singh on the basis of Consensual Transfer Policy vide No. 3117 dated 28.03.2019.

The Dwelling Unit was cancelled vide order dated 07.10.2019 due to Building violation the same was conveyed to this office vide Endst. No. HB/EE (Enf)/SDE-X(Enf.)/2019/410 dated 07.10.2019.

Whereas, on 31.03.2023, **worthy Chairman, Chandigarh Housing Board, Chandigarh** has passed orders for revival/restoration of the Dwelling Unit subject to get violation (i.e. Glazing of Verandah / Balcony) regularized and deposit of applicable revival / restoration chages / other charges, if any within three months time.

Whereas, it has been informed by Enforcement Office on 25.04.2023 that allottee/occupant has got the violations regularized under NBC vide Arch letter No. 886756 dated 13.04.2023.

Further, you have deposited the Revival Charges amounting to Rs. 1,24,878/- including GST on 20.07.2023.

Accordingly, the allotment of dwelling unit No. 2210-1, Cat. MIG, Sector 45-C, Chandigarh is hereby revived/restored on the original terms and conditions as per allotment dated 20.03.1989.
