Whereas the allotment and registration of Dwelling Unit No. 3122, Category LIG, Sector 45 D, Chandigarh was allotted to Sh. Hari Har Singh Bhardwaj S/o Sh. Ramji Singh Bhardwaj vide Allotment Letter No. 812 dated 28.08.1985.

And whereas Registration/Allotment of dwelling unit No. 3122, Cat. LIG, Sector 45 D Chandigarh which was transferred in your name had been cancelled vide No. 742 dated 05.11.2019 due to Building violation in terms of provision of clause 19 of the allotment letter on account of breach of terms and conditions of allotment and also the provision of Regulation, 17 of Chandigarh Housing Board (Allotment management and Sale of Tenements) Regulation, 1979.

And whereas your appeal was placed before the Chairman, CHB on 19.05.2023. The Board resolved that D.U. No. 3122 Cat. LIG, Sector 45 D, Chandigarh may be restored subject to payment of revival charges as per existing policy.

Whereas, you have deposited the Revival Charges Rs.71,902/- (including GST) on 09.08.2023.

Now, therefore, the allotment of dwelling unit No.3122, Cat. LIG, Sector 45 D, Chandigarh is hereby revived on the original terms and conditions as per allotment dated 28.08.1985.
