Hence, from the above, it is evident that you have not occupied your originally allotted Small Flat No.2703-3, Sector 49, Chandigarh, but, unauthorized occupants are still residing at above said flat and you have failed to comply the order dated 23,10,2023 of the Secretary Estates-cum-Appellate Authority, UT, Chandigarh issued in respect to your Appeal No.0036/2023.

Therefore, the cancellation order dated 17.05.2023 of Small Flat No.2703-3. Sector 49, Chandigarh has been kept in force in compliance of order dated 23.10.2023 of the Secretary Estates-cum-Appellate Authority, UT, Chandigarh.
