ORDER

- Whereas the DU No. 2207/1, Sector 45C, Chandigarh was allotted on lease hold basis to Sh. Tilak Raj Sharma Slo Sh. Babu Ram Sharma on the terms and conditions: stipulated in the allotment letter No. 624, dated 20.03.1989, Registration No. 7217.
- And whereas, as per the condition of the allotment letter, the dwelling unit could be used for the purpose of residence only and not for any other purpose. No additions/alterations could be made therein without prior approval of the Board in
- And whereas, it had come to the Notice of the Board that the following violations 3 have been made in the dwelling unit:
 - Sit out on illegal construction of ground floor (fresh)
 - Back Veranda converted into room (old)
 - Room, toilet, Verandah in front in Govt. Land/Garrage area (old)
 - Shed with glazing on illegal construction of ground floor (old)
- And whereas, it is clear that the aflottee occupant had acted in contravention to the provisions contained in clause 15 allotment letter and also the provision of Regulation 1.7 of the Chandigarh Housing Board (Allotment, Management and Sale of Tenements) Regulations, 1979.
- And whereas, a Show Cause Notice No. CHB/EE-Enf/SDE(X)/2017/68 dated 07:04:2017 was served on the allottee/occupant vide which he had been called upon to show cause in writing/personal hearing on 24.04.2017 at 03:00 PM as to why the Registration and Allotment/Tenancy of D/Unit No. 2207/1, Sector 45C, Chandigarh be not cancelled/resumed and amount forfeited as per terms of the Allotnient letter and further action to evict him from the dwelling unit by following the procedure prescribed under rules as framed under Chapter VI of Haryana Housing Board act 1971 etc., as extended to UT of Chandigarh.
- 'And whereas, the allottee/occupant did not remove the victations/encroachments despite having been given number of opportunities for hearings for removing the said encroachments/ violations. The following violations and encroachments still exist in the Dwelling Unit:
 - Sit out on illegal construction of ground floor (fresh)
 - Back Veranda converted into room (old)
 - Room, toilet. Verandah in front in Govt. Land/Garrage area (old)
 - Shed with glazing on illegal construction of ground floor (old)
- And whereas in the proceedings dated 26.10.2023, the allottee did not appear 7: Enforcement Officer was accordingly directed to carry out the fresh inspection and put up cancellation order for the dwelling unit if the violations still exist
- And whereas, an inspection was carried out on 30.11.2023 by the Enforcement ိ. Wing and it has been reported that none of the above building violations/encreachment have been removed from the said dwelling unit.
- Now, therefore, in view of the above facts & circumstances, the undersigned is left with no option but to cancel the registration/ allotment of D.U. No. 2207/1. Sector 45C, Chandigarh. The amount deposited by the allottee stands forfeited in terms of the provisions of the allotment letter on account of breach of terms and conditions of the allotment letter and also the provisions of Section 17 of



Chandigath Housing Board (Allotment, Management and Sale of Legements) Regulations, 1979

The allottee/occupant is further advised to hand over the possession of divelling uilt in question to the Chief Englineer, Chandigarh Housing Board, Chandigarh within 30 days from the date of issue of this order failing which existing proceedings shall be initiated against the allotted for eviction from the rand premises from the un-authorized possession.
