ORDER

- 1. Whereas the DU No. 3250, Sector 40/D, Chandigarh was allotted on lease hold basis to Sh. Kewal Krishan Arora on the terms and conditions stipulated in the allotment letter No. 3732, dated 03.07.1981, Registration No. 9585. The D.U. was transfered in the name of Sh. Narinder Kumar S/o Sh. Ram Krishan vide No. 31584 dated 19.04.2017 on the basis of GPA/Sub GPA transfer policy.
- 2. And whereas, as per the condition of the allotment letter, the dwelling unit could be used for the purpose of residence only and not for any other purpose. No additions/alterations could be made therein without prior approval of the Board in writing.
- 3. And whereas, it had come to the Notice of the Board that the following violations have been made in the dwelling unit:
 - Room constructed with RCC slab in rear courtyard (old)
 - Further stair in rear courtyard for approached to the roof of the room in rear courtyard using same for washing, sitting etc. (old)
 - Steel IRC fixed as parapet with RCC Slab (old)
 - Fiber Glass Sheet shed installed on the roof of rear courtyard (old)
- And whereas, it is clear that the allottee/occupant had acted in contravention to the 4. provisions contained in clause 15 of allotment letter and also the provision of Regulation 17 of the Chandigarh Housing Board (Allotment, Management and Sale of Tenements)
- And whereas, a Show Cause Notice No. CHB/ENF./DY.EO-I/2020/1222 dated 5. 05.11.2020 was served on the allottee/occupant vide which he had been called upon to show cause in writing/personal hearing on 21.01.2021 at 10:00 AM as to why the Registration and Allotment/Tenancy of D/Unit No. 3250, Sector 40/D, Chandigarh be not cancelled/resumed and amount forfeited as per terms of the Allotment letter and further action to evict him from the dwelling unit by following the procedure prescribed under rules as framed under Chapter VI of Haryana Housing Board act 1971 etc., as extended to UT of Chandigarh.
- And whereas, the allottee/occupant did not remove the violations/encroachments despite 6. having been given number of opportunities for hearings for removing the said encroachments/ violations. The following violations and encroachments still exist in the
 - Room constructed with RCC slab in rear courtyard (old)
 - Further stair in rear courtyard for approached to the roof of the room in rear courtyard using same for washing, sitting etc. (old) Steel IRC fixed as parapet with RCC Slab (old)

 - Fiber Glass Sheet shed installed on the roof of rear courtyard (old)
- And whereas, in the proceedings dated 18.07.2024, the allottee did not appear. The ex-7. parte decision has been taken by the W/Chief Executive Officer, CHB, and directed to Enforcement Officer to put up cancellation order for the dwelling unit.
- Now, therefore, in view of the above facts & circumstances, the undersigned is left with no 8. option but to cancel the registration/ allotment of DU No. 3250, Sector 40/D, Chandigarh. The amount deposited by the allottee stands forfeited in terms of the provisions of the allotment letter on account of breach of terms and conditions of the allotment letter and also the provisions of Section 17 of Chandigarh Housing Board (Allotment, Management and Sale of Tenements) Regulations, 1979.
