And whereas Registration & Allotment of dwelling unit No. 3233-1, Category LIG, Sector 47-D, Chandigarh which was transferred in your favour had been cancelled vide order dated 26.10.2023 due to Building violation/encroachments in terms of provision of the allotment letter on account of breach of terms and conditions of allotment and also the provision of Regulation, 17 of Chandigarh Housing Board (Allotment management and Sale of Tenements) Regulation, 1979.

Now, therefore, the allotment of dwelling unit No. 3233-1, Cat. LIG, Sector 47-D, Chandigarh is hereby revived on the original terms and conditions as per allotment letter dated 01.01.1979.
