SPEAKING ORDER

- 1. That an SCN for resumption of allotment of DU No. 271, Sector-55, Chandigarh was issued for the ongoing fresh un-authorized/ illegal construction/alteration made in the dwelling unit vide no. 1838696 dated 14.11.2024 for the following violation:-
 - (i) Room constructed in rear courtyard.
 - (ii) M.S. Grill provided over the room of room in rear courtyard.
 - (iii) Gate opened towards roadside in rear courtyard.
 - (iv) Verandah covered and merged with kitchen.
 - (v) Fiber shed in rear courtyard.
- 2. That the DU No. 271, Sector-55, Chandigarh was inspected by the Enforcement wing on 05.12.2024 & 24.01.2025. The status of violations are as under after various inspections:-

- 3. That in the personal hearing before the undersigned on dated 30.01.2025 Sh. Gurcharan Singh Bola allottee/occupant of DU No. 271, Sector-55, Chandigarh has submitted the structural stability certificate for the said flat regarding violation no.(v) above.
- 4. In view of the report of Enforcement Wing, CHB regarding removal of the violation, mentioned in the SCN to the allottee/occupant vide no. 1838696 dated 14.11.2024 is hereby disposed off subject to payment of penalty charges if any levied in future
- 5. That no further additional Construction is to be made without prior approval of Chandigarh Housing Board.
