

**EVICTON ORDER**

**U/s 51 Sub-Section (1) of Haryana Housing Board Act  
(as extended to Chandigarh)**

To

Sh.Pritpal Singh S/o Sh.Arjun Singh /Occupant  
House No.4322, Sector 39 (West) Maloya Colony  
Chandigarh

Whereas, the undersigned is satisfied that you have unauthorizedly occupied the **Dwelling Unit No.4322, Sector 39 (West) Maloya Colony, Chandigarh** from **06.06.2019**. The allotment of the dwelling unit has been cancelled by the Chandigarh Housing Board, Chandigarh vide order **No.232-35 dated 06.06.2019** due to building violations.

And whereas, you had filed an appeal before the Chairman, CHB on 16.07.2019, your appeal was heard by W/Chairman, CHB on 22.01.2020 and ordered that you will remove the violations / encroachments within one month otherwise cancellation order dated 06.06.2019 passed by the Chief Executive Officer, CHB shall remain in force. The order was communicated to you vide No.221-24 dated 03.02.2020.

And whereas vide **Eviction Notice No.650 dated 11.03.2020**, you were directed to tender an explanation and produce evidence, if any, within 14 days from the date of the service of the notice. But you failed to tender an explanation and produce evidence.

And whereas you have acted in contravention of the terms & conditions under which you were authorized to occupy and use the premises schedule given below **Dwelling Unit No.4322, Sector 39 (West) Maloya Colony, Chandigarh**.

Now, therefore, in exercise of the Powers conferred on me by Sub-Section (1) of Section 51 of Haryana Housing Board, Act, 1971 as extended to the Union Territory of Chandigarh, I hereby order you (as well as other occupants who is/are in occupation of the whole/a part of the said premises), to vacate the said premises within **one month** from the date of service of this notice, failing which you may be evicted forcibly unless you comply with the terms contravened by you.
