

EVICTION ORDER
U/s 51 Sub-Section (1) of Haryana Housing Board Act
(as extended to Chandigarh)

To

Smt.Sushma Devi W/o Sh.Rajbir /Occupant
House No.4901, Small Flat, Sector 38 (West)
Chandigarh

Whereas, the undersigned is satisfied that you have unauthorizedly occupied the **Small Flat No.4901, Sector 38 (West), Chandigarh from 17.05.2023**. The allotment of the said Small Flat has been cancelled by the Chandigarh Housing Board, Chandigarh vide Secretary-cum-Competent Authority, Under Chandigarh Small Flats Scheme-2006, CHB, Chandigarh order **No.7958 dated 17.05.2023** due to violation of under Clause no.4 & 5 deed of license.

And whereas, you had filed an appeal bearing No.0039/2023 before the Secretary, Estates, UT, Chandigarh which was dismissed by the Competent Authority on 26.03.2024. Now, you have again filed a Revision Petition No.26 of 2024 under Section 17-E before the Advisor to the Administrator, UT, under Chandigarh Small Flats Scheme-2006 but there is no stay / injunction is pending in favour of your dwelling unit.

And whereas vide **Eviction Notice No.178 dated 05.06.2024**, you were directed to tender an explanation and produce evidence, if any, within 14 days from the date of the service of the notice. But you failed to tender an explanation and produce evidence.

And whereas you have acted in contravention of the terms & conditions under which you were authorized to occupy and use the premises schedule given below **Small Flat No.4901, Sector 38 (West), Chandigarh**.

And whereas, in exercise of the Powers conferred on me by Sub-Section (1) of Section 51 of Haryana Housing Board, Act, 1971 as extended to the Union Territory of Chandigarh, I hereby order you (as well as other occupant of DU No. who is/are in occupation of the whole/a part of the said premises) to vacate the said premises within **one month** from the date of service of this notice, failing which you may be evicted forcibly unless you comply with the terms contravened by you.
