
Subject:- Revival of allotment of Small Flat No.2517-B, Ram Darbar, Chandigarh.

Reference to the order dated 12.02.2026 passed by the Appellate Authority-cum-Secretary Estates, U.T., Chandigarh in respect of Appeal No. 89/2025.

1. Whereas you were allotted Small Flat No.2517-B, Ram Darbar, Chandigarh under the Chandigarh Small Flat Scheme-2006 on licence basis for a period of 20 years vide Memo No. CHB/CHSFS/2006/1031 dated 24.05.2010 on the terms and conditions stipulated in the allotment letter and Deed of Licence.
2. And whereas the allotment/licence of Small Flat No.2517-B, Ram Darbar, Chandigarh allotted to you was cancelled vide Order No. 2078 dated 30.01.2025 by the competent authority, CHB due to non-payment of monthly licence fee.
3. And whereas you preferred an appeal before the Appellate Authority-cum-Secretary Estates, U.T., Chandigarh against the cancellation order dated 30.01.2025, and the Appellate Authority vide Order dated 12.02.2026 set aside the aforesaid cancellation order in respect of Small Flat No.2517-B, Ram Darbar, Chandigarh, whereby the said flat has been restored to the original licensee in accordance with the provisions of the Chandigarh Small Flat Scheme, 2006.
4. And whereas, you were requested vide this office Letter No. 18132 dated 02.04.2026 to deposit the revival charges amounting to Rs.18,912/- (i.e. Rs.16,027/- plus GST @ 18% amounting to Rs.2,885/-) along with the outstanding licence fee dues of Rs.126/- (up to 13.03.2026). In response thereto, you deposited the aforesaid revival charges vide online payment receipt dated 08.04.2026, and the same has been duly verified from the online payment statement. Further, the outstanding licence fee dues in respect of the said flat have also been found cleared and verified up to 20.05.2026.

Now, therefore, Small Flat no.2517-B, Ram Darbar, Chandigarh is hereby revived on the original terms and conditions as mentioned in the allotment letter and Deed of License.






