ORDER

- 1. Whereas the DU No. 4579, Maloya, Chandigarh was allotted on lease hold basis to Sh. Janak Raj S/o Sh. Prem Chand on the terms and conditions stipulated in the allotment letter No. 485, dated 30.01.1989, Registration No. 3026.
- 2. And whereas, as per the condition of the allotment letter, the dwelling unit could be used for the purpose of residence only and not for any other purpose. No additions/alterations could be made therein without prior approval of the Board in writing.
- 3. And whereas, it had come to the Notice of the Board that the following violations have been made in the dwelling unit:
 - Ground floor fully covered with RCC Slab.
 - Ist floor fully covered with RCC slab.
 - Ilnd floor fully covered with RCC slab.
 - Chhajja extended on govt land front side of the house up to llnd floor work in progress.
- And whereas, it is clear that the allottee/occupant had acted in contravention to the provisions contained in clause 14 of allotment letter and also the provision of Regulation 17 of the Chandigarn Housing Board (Allotment, Management and Sale of Tenements) Regulations, 1979.
- 5. And whereas, a Show Cause Notice No. CHB/EE-PH-SDE-(Enf)III/2015/106-112 dated 15.04.2015 was served on the allottee/occupant vide which he had been called upon to show cause in writing/personal hearing on 01.07.2015 at 03:00 PM as to why the Registration and Allotment/Tenancy of D/Unit No. 4579, Maloya, Chandigarh be not cancelled/resumed and amount forfeited as per terms of the Allotment letter and further action to evict him from the dwelling unit by following the procedure prescribed under rules as framed under Chapter VI of Haryana Housing Board act 1971 etc., as extended to UT
- 6. And whereas, the allottee/occupant did not remove the violations/encroachments despite having been given number of opportunities for hearings for removing the said encroachments/ violations. The following violations and encroachments as per latest inspection report dated 29.01.2024, still exist in the Dwelling Unit :-

- And whereas, after consultation with the Senior Law Officer and the Chief Accounts 8. Officer, CHB, the Enforcement Officer was directed to initiate the process for issuance of the cancellation order.
- Now, therefore, in view of the above facts & circumstances; the undersigned is left with 9. no option but to cancel the registration/ allotment of D.U. No. 4579, Maloya, Chandigarh. The amount deposited by the allottee stands forfeited in terms of the provisions of the allotment letter on account of breach of terms and conditions of the allotment letter and also the provisions of Section 17 of Chandigarh Housing Board (Allotment, Management and Sale of Tenements) Regulations, 1979.
