

EVICTION ORDER
U/s 51 Sub-Section (1) of Haryana Housing Board, Act
(as extended to Chandigarh)

To

Sh. Balwant Singh S/o Sh. Sarup Singh / Occupant
Site No. 1608, Sector 39 (West) Dadumajra Colony
Chandigarh

Whereas I, the undersigned, am satisfied that you have unauthorisedly occupied the Site No. 1608, Sector 39 (West) Dadumajra Colony, Chandigarh from 15.02.2023. The allotment of the said site No. 1608 has been cancelled by the Chief Executive Officer, Chandigarh Housing Board, Chandigarh vide order No. 3222-23 dated 21.02.2023 due to violation of clause no. 4 deed of license states as under:-

"The lessee shall not sublet, assign or otherwise part with possession of the Transit Site or any part thereof in favour of any person whatsoever".

And whereas vide Eviction Notice No. 744 dated 03.04.2023, you were directed to tender an explanation and produce evidence, if any, within 14 days from the date of the service of the notice.

And whereas an appeal No. 05/2023 was filed before the Chief Secretary-cum-Chairman, CHB, Chandigarh, which was dismissed by the Competent Authority on 29.05.2025. The order was communicated to you vide No. HB/S(A)/2025/917 dated 05.06.2025.

And thereby you have acted in contravention of the terms & conditions under which you were authorized to occupy and use the premises schedule given below Site No. 1608, Sector 39 (West) Dadumajra Colony, Chandigarh

Now, therefore, in exercise of the Powers conferred on me by Sub-Section (1) of Section 51 of Haryana Housing Board, Act, 1971 as extended to the Union Territory of Chandigarh, I hereby again order you (as well as other occupants who is/are in occupation of the whole/a part of the said premises), to vacate the said premises within **one month** from the date of service of this notice, failing which you may be evicted forcibly unless you comply with the terms contravened by you.
