ORDER

1. Whereas the DU No. 199/2, Sector 41, Chandigarh was allotted on lease hold basis to Sh. Kushal Pal S/o Sh. Dasoundhi Ram on the terms and conditions stipulated in the allotment letter No. 1202, dated 28.12.1982, Registration No. 235. It was transferred in the name of Sh. Diwan Singh Mehra S/o Bachchi Singh vide no. 29391 dated 30.12.2016 on the basis of GPA/SPA/Sub GPA transfer policy.
2. And whereas, as per the condition of the allotment letter, the dwelling unit could be used for the purpose of residence only and not for any other purpose. No additions/alterations could be made therein without prior approval of the Board in writing.
3. And whereas, it had come to the Notice of the Board that the following violations have been made in the dwelling unit:
 - Room Constructed with Kitchen & Toilet on terrace.
 - M.S. Stair fixed to approach terrace.
 - M.S. Jali fixed.
 - M.S. Railing fixed, Common area extended.
4. And whereas, it is clear that the allottee/occupant had acted in contravention to the provisions contained in clause 15 of allotment letter and also the provision of Regulation 17 of the Chandigarh Housing Board (Allotment, Management and Sale of Tenements) Regulations, 1979.
5. And whereas, a Show Cause Notice No. CHB/ENF./DY.EO-I/2021/872 dated 29.07.2021 was served on the allottee/occupant vide which he had been called upon to show cause in writing/personal hearing on 02.09.2021 at 10:00 AM as to why the Registration and Allotment/Tenancy of D/Unit No. 199/2, Sector 41, Chandigarh be not cancelled/resumed and amount forfeited as per terms of the Allotment letter and further action to evict him from the dwelling unit by following the procedure prescribed under rules as framed under Chapter VI of Haryana Housing Board act 1971 etc., as extended to UT of Chandigarh.
6. And whereas, the allottee/occupant did not remove the violations/encroachments despite having been given number of opportunities for hearings for removing the said encroachments/ violations. The following violations and encroachments still exist in the Dwelling Unit :-
 - Room Constructed with Kitchen & Toilet on terrace.
 - M.S. Stair fixed to approach terrace.
 - M.S. Jali fixed.
 - M.S. Railing fixed, Common area extended.
7. And whereas, in the proceedings dated 27.03.2025, Smt. Parvati appeared on behalf of Sh. Diwan Singh. She again requested for some time to remove the violations. However, it has been noticed that the allottee is not removing the violations despite a number of opportunities. Enforcement Officer was directed to inspect the dwelling unit and put up orders for cancellation of dwelling unit if the violations are still existing.
8. And whereas, the DU No. 199/2, Sector 41, Chandigarh was inspected by Enforcement branch on 19.05.2025, the inspection report is reproduced as follows:-

3.	M.S. Jali fixed.	Still exists
4.	M.S. Railing fixed, Common area extended.	Still exists

9. Now, therefore, in view of the above facts & circumstances, the undersigned is left with no option but to cancel the registration/ allotment of D.U. No. 199/2, Sector 41, Chandigarh. The amount deposited by the allottee stands forfeited in terms of the provisions of the allotment letter on account of breach of terms and conditions of the allotment letter and also the provisions of Section 17 of Chandigarh Housing Board (Allotment, Management and Sale of Tenements) Regulations, 1979.
10. The allottee/occupant is further advised to hand over the possession of dwelling unit in question to the Chief Engineer, Chandigarh Housing Board, Chandigarh within 30 days from the date of issue of this order failing which eviction proceedings shall be initiated against the allottee for eviction from the said premises from the un-authorized possession.
