You shall keep number of paying guest as per norms fixed by the Chandigarh Administration 4. & CHB.

The permission can be withdrawn at any time in case of breach of any clause of the policy.

The applicant/ owner will be responsible for any loss of life/ property caused due to any misshappening in this PG facility.

You shall be liable to pay any amount found due or in arrears towards the price of said dwelling unit and interest etc.

You shall also abide by the terms and conditions as laid down in the allotment letter as well as in the Deed of conveyance.

You shall not fragment the dwelling unit in any manner.

10. The Paying Guest Residential Accommodation shall be open to the inspection by the Chandigarh Housing Board or any officer approved/authorized by Chandigarh Housing Board from time to time.

The permission is granted on the basis of documents including the NOC issued by the Chief Fire Officer, U.T., Chandigarh, submitted by you at your risk and cost. The Chandigarh Housing Board will not be responsible for any litigation at any stage. If the applicant has submitted any false /wrong information, forged/fabricated document or has concealed any material information/facts, permission/letter stands withdrawn.

In the event of your failure to comply with the above mentioned terms and conditions and further instructions issued, if any, proceedings under Section 8-A of the Capital of Punjab (Development & Regulation), Act, 1952 as amended up-to date and the rules framed there-under from time to time for the resumption of property shall be initiated against you.
