Whereas the dwelling unit No. 2829 Cat. OBR Sector 49, Chandigarh against Registration No. 19 had been allotted to you as a result of draw of lots held on 29.07.2009 on Basis on the terms and conditions stipulated in the allotment letter No. 300 dated 15.09.2009.

And whercas Registration/Allotment of dwelling unit No. 2829, Category OBR, Sector 49, Chandigarh allotted to you was cancelled vide No.HB/SDE-E-IV(Enf.)/2018/277 dated 01.10.2018 due to Building violation in terms of provision of the allotment letter on account of breach of terms and conditions of allotment and also the provision of Regulation, 17 of Chandigarh Housing Board (Allotment management and Sale of Tenements) Regulation, 1979.

Whereas as per report of Enforcement Officer received vide No.Dy.EO-II/2025/667 dated 30.03.2025 the violation has been removed. Accordingly as per order of Chief Executive Officer 07.03.2025 this office has conveyed the revival charges vide this office letter No. 7415 dated 07.04.2025 and letter no. 20171 dated 28.07.2025.

Whereas, you have deposited the Revival Charges Rs. 118976/- (Rs. 100827/- as revival charges+ Rs 18149/- as GST) on dated 21.04.2025 and Rs 26863/- (Rs. 22765/- as revival charges + Rs 4098/- as GST) on dated 01.08.2025 in view of the above order.

Now, therefore, the allotment of dwelling unit No. 2829, Cat. OBR, Sector 49, Chandigarh is hereby revived on the original terms and conditions as per allotment letter dated 15.09.2009.



