

**(Eviction Notice)**  
**U/s 51 Sub-Section (1) of Haryana Housing Board, Act**  
**(as applicable to Chandigarh)**

Sh. Hari Om Soni & Smt. Parveen Soni,  
Resident of D.U.No. 939/1, Sector 40-A,  
Chandigarh.

Whereas I, the undersigned, am satisfied that you have unauthorisedly occupied the H.No. 939/1, Sector 40-A, Chandigarh from 11.08.2019, the allotment of the dwelling unit No. 939/1, Sector 40-A, Chandigarh has been cancelled by the Chandigarh Housing Board, Chandigarh on 11.08.2019 and thereby have acted in contravention of the terms under which you were authorized to occupy and use the premises described in the Schedule appended hereto:-

1. Kitchen of size 9' - 3" x 7' - 3" (67 Sft) constructed in verandah at First floor.
2. Toilet of size 7' 1 - 1/2" x 7' - 3" (52 Sft) constructed in verandah at first floor.
3. Room constructed of size 9' - 3" x 11'-3" (104.06 Sft) at second floor.
4. Kitchen constructed at 6' - 4 1/2" x 11' - 3" (72 Sft) at second floor.
5. Room constructed of size 10' - 6" x 19'-3" (202 Sft) at second floor.
6. Pooja Room constructed of size 9' - 3" x 7' - 3" (67 Sft) at second floor.
7. Covered verandah of size 6' - 4 1/2" x 8' - 0" (51 Sft) at second floor.

And whereas, in Exercise of the Powers conferred on me by Sub Section (1) of Section 51 of the Haryana Housing Board Act, 1971, as extended to the Union Territory of Chandigarh, I propose to order you (as well as other occupant of **H. No. 939-1 Sector 40-A Chandigarh**, who is/are in occupation of the whole/a part of the said premises) to vacate the said premises within one month from the date of service of notice under Sub-Section (1) of Section 51 of the act, on the grounds aforesaid (herein after referred to as the proposed orders)

Now, therefore, as required by the provisions of Sub-Section (1) of section 51, I call upon you to tender an explanation and produce evidence, if any, on \_\_\_\_\_ dated \_\_\_\_\_ and Show Cause within **14 days**, from the date of the service of this notice why the proposed orders should not be made.
