
Whereas the allotment of said dwelling unit was cancelled by the competent authority vide Endst No. HB/E.O./Dy.E.O-I/2022/542 dated 12.05.2022 due to breach of terms and conditions of allotment, under the provision of Regulation, 17 of Chandigarh Housing Board (Allotment management and Sale of Tenements) Regulation, 1979.

And whereas, your appeal against the orders dated 12.05.2022 was allowed by the Chief Executive Officer, Chandigarh Housing Board, Chandigarh on 21.02.2025 and the Registration/Allotment of dwelling unit No. 5691, Cat. MIG, Sector 38-W, Chandigarh was revived/restored in your favour subject to payment of revival charges as per existing policy.

Whereas, you have deposited the Revival Charges amounting to Rs.1,89,830/- (Rs. 1,60,873/- plus GST Rs.28,957/-) on 02.01.2026.

Now, therefore, the allotment of dwelling unit No. 5691, Cat. MIG, Sector 38-W, Chandigarh is hereby revived/restored on the original terms and conditions as per allotment letter dated 07.01.2000.

This issues with the approval of the Chief Executive Officer, Chandigarh Housing Board, Chandigarh dated 15.01.2026.


